## PENNSYLVANIA STATE USBC BA MIXED TOURNAMENT RULES

1. All entries and competition in this tournament must be in accordance with the rules and regulations of the United States Bowling Congress and the PSBA.
  2. Appropriate USBC membership must be verified prior to bowling. Participants not in possession of a USBC card must file an affidavit of membership based on fees charged by the bowler's local association.
  3. Tournament will consist of Team (2 men & 2 women) and Doubles (1 man & 1 woman) and optional 6 game All Events.
  4. **MULTIPLE PARTICIPATION:** Bowlers may participate more than once in team and doubles provided at least two (2) members on a team and one (1) member on a doubles entry are changed. A bowler's first appearance (including substitutions) in each event shall count towards all events score for prizes.
  5. No more than one individual at time of entry who is a current member, or has applied for membership in any bowling organization which identifies itself as "professional" may compete on a four member team. Likewise, only one individual may compete on a doubles team.
  6. A reimbursable entry (for all 3 events - team, doubles and all events) will be given to a sponsor of 7 or more entries who:
    - . Schedules the entries on 1 squad or weekend, and
    - . Enters the team members in team and doubles
  7. Substitutions may be used when necessary as long as such substitute meets all rules of eligibility. No substitute will be accepted for all events participation when any one event, or portion of any event has been bowled by the original entrant or substitute. Substitutes must bowl in the same position as the original bowler and must be the same sex. Failure of the sub or team captain to sign substitution affidavit shall void any prize winning disputes.
  8. Contestants shall bowl in order as submitted on the entry. Team captains shall check in **ONE HOUR PRIOR TO STARTING TIME** and substitutions shall be made at that time. Two four member teams may be paired on the same lanes if they so request and submit entries together.
  9. Fees in full must accompany each entry. Advance reservations will be held only until April 1. Other entries must be submitted one (1) week prior to the last day of the tournament; midnight Sunday, July 25, 2010. Order of receipt of entry fees will govern assignment of dates and squad times. **ALL ENTRIES MUST BE IN THE HANDS OF THE TOURNAMENT DIRECTOR AT LEAST ONE (1) WEEK BEFORE DATE SCHEDULED TO BOWL; NO WALK-IN ENTRIES WILL BE ACCEPTED.**
  10. Bowlers from *the host association and associations* within a 50 mile radius will be scheduled based on squad and lane availability except in emergencies.
  11. **AVERAGES:** Entrants shall use their highest USBC previous season's winter league average, 21 games or more. If no winter league average, entrants may use their highest summer league average, 21 games or more. If no winter or summer league average for the previous season, entrants may use their highest average for the "current season". 21 games or more as of May 1. **ALL OTHERS BOWL SCRATCH. IF AT THE TIME OF BOWLING ENTRANTS CURRENT SEASONS AVERAGE OF 21 GAMES OR MORE IS 10 PINS OR MORE HIGHER THAN THE PREVIOUS SEASONS AVERAGE OF 21 GAMES OR MORE. THE HIGHEST AVERAGE MUST BE USED.**
  12. Handicap is 90% of 2640 scratch for team; 1320 scratch for doubles and 660 scratch for the optional no bowl singles.
  13. Prize ratio for team & doubles will be at least 1 in 5, and for all events 1 in 10.
  14. Prize winnings for previous 12 months must be reported if they are \$600.00 in any event. USBC Rule 319A-2, 319A-3, 319C, and 319D applies to all entrants regardless of average.
  15. Prize fees will be returned 100 percent.
  16. **NO PRACTICE ON ANY SCHEDULED TOURNAMENT LANES THAT DAY.**
  17. Lane assignments for each event of this tournament shall be scheduled by the tournament management.
  18. Awards of same type and quality will be awarded to scratch champion and handicap winners in each event.
  19. In the event of a tie for first place in any event co-champions shall be declared.
  20. All decisions of the tournament manager / on-site tournament manager are final unless an appeal is made in accordance with USBC Rule 329.
  21. Individual overpayments of \$5.00 or less will not be refunded.
  22. Failure to comply with above rules shall result in disqualification of scores.
- NO BOWL SINGLES**
1. Rules 1 thru 22 shall apply with the following exceptions.
  2. Team Event scores will be used for No Bowl Singles.
  3. No USBC or on-site awards will apply for No Bowl Singles.
  4. You may re-enter as many times as you bowl team event, and only place once in the highest final prize list position.
  5. Singles event shall not be considered towards all events.
  6. Prize ratio is 1 in 5, (Handicap 66 2/3%, Scratch 33 1/3%)
